Foreign citizens, people with residence permit and stateless persons permanently residing on the territory of the Republic of Belarus on legal grounds, wishing to be admitted to the clinical residency on a feepaid basis, should submit the following documents:

- Copy of passport, or other document, verifying applicant's identity;
- Diploma of Higher Medical Education (copy and original);
- Academic Transcript with the list of the subjects studied and the grades obtained (copy and original);
- Notarized translation of these documents into Russian;
- Copy of certificate on acknowledgment of Diploma of Higher Medical Education, given in any other university beyond the territory of Belarus, issued by the Republican Institute of Higher Education;
- Standard medical certificate issued by the local public health authorities of the Republic of Belarus;
- 3 photos (3 x 4 cm).

Clinical residency training is carried out according to the curricula and educational programs approved by the Ministry of Health of the Republic of Belarus: <u>minzdrav.gov.by</u>
