It is advisable to refrain from including review articles, retrospective studies, and articles sponsored by the industry.

Ideally, the journal should possess an impact factor, be subjected to peer review, and be indexed with both national and global reach.

• Authorization from the faculty is required.

3.Presentation of Article

3.1 TITLE OF THE ARTICLE

- Simple and concise
- Variables to be specific
- Should contain independent and dependent variable
- May also reflect study design

3.2 AUTHORS AND FUNDING SOURCE

- Who are the authors? Are you acquainted with any of their previous scholarly contributions? Has their work consistently demonstrated reliability?
- The Institution/Organization to which the authors are affiliated and their respective professional titles, their contact number, and email address ought to be indicated.
- By whom was the study financed? This imparts initial insight into discerning the various predispositions to be vigilant for.

3.3 SHORT INTRODUCTION ABOUT JOURNAL SELECTED

- Organization of which institution
- Impact factor : if any
- Peer reviewed or not
- Indexed or not
- National/International

Impact factor

 The JOURNAL CITATAION REPORTS (JCR) furnishes a quantitative instrument for the purpose of ranking, evaluating, and categorizing various journals. The JCR impact factor, which is calculated yearly, is a proportion between the number of citations and the recent citable items publications.

3.4 ABSTRACT & KEY WORDS

ABSTRACT

• The condensed version of the entire article, which includes the research design, objective, methodology, result, and conclusion, should be formatted in accordance with the guidelines provided by the journal.

KEY WORDS:

• As per the guidelines established by the journal, the majority of the content is derived from the title, thereby facilitating a simplified process of locating article.



3.5 INTRODUCTION

The following is a general introduction and context for the article, which includes :

- The research question is clearly presented, and the objective or purpose of the study is stated with clarity.
- The hypothesis is also clearly stated.

3.6 MATERIAL AND METHODS

- Study design
- Source of data, place of study, and duration of trial
- Whether GCP guidelines followed
- Inclusion/Enrollment criteria Exclusion criteria
- Sample size Treatment schedule (dose, form, mode of administration and duration)
- Laboratory investigations (diagnostic, safety)
- Criteria for assessment (subjective and objective parameters)
- Statistical analysis

3.7 STUDY DESIGN

- Randomized double blind controlled trial
- Open observational clinical
- Case series
- Cohort study (epidemiological)
- Case-control/Non-experimental
- Cross-sectional/Prevalence

3.8 RESULTS

- Demography data Clinical response (Subjective parameters)
- Scales/Scores/Indices (Semi objective parameters)
- Laboratory/Imaging tests (Objective parameters)
- Generally summarized in tables/graphs
- Consider both the statistical significance and the effect size-the magnitude of difference between the groups.

3.9 DISCUSSION

Deals with the interpretation of results.

- What is the meaning that can be derived from the study's results?
- What are the potential strengths, limitations, biases, or flaws of the study?
- Assess the probability that each bias has impacted the study's validity, and determine the direction in which it would influence the results.
- Establish a correlation between the current findings and previous studies that are relevant.

3.10 CONCLUSION

- 1. Was the objective of the study successfully accomplished?
- 2. Did it address the research question?
- 3. What are the primary and secondary outcomes of the study? In terms of the study's application, does the information prove beneficial to medical practice?
- 4. Does it propose ideas for future research?
